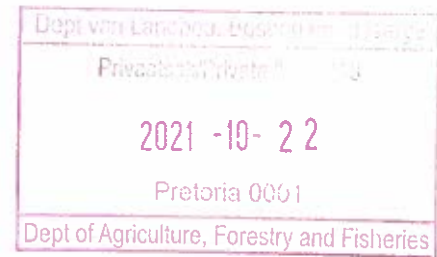

**RE: RENEWAL OF FARM FEEDS REGISTRATIONS IN TERMS OF FERTILIZERS, FARM FEEDS,
AGRICULTURAL REMEDIES AND STOCK REMEDIES ACT, 1947 (ACT NO. 36 OF 1947)**

1. Kindly note that your current farm feed registration(s) is/are valid until **Thursday 31 March 2022** and should be renewed for the renewal cycle ending in **31 March 2025**.

2. Please note the following:

A. REGISTRATION(S) RENEWAL: FORM A

- (a) List all the products, whose registration must be renewed, on the attached Form A.
- (b) Form A must be completed in **duplicate**.
- (c) An **authentic signature** is required on the declaration page of Form A and it is compulsory to have the declaration commissioned / attested by the Commissioner of Oath.
- (d) You are kindly requested to also submit the copies of the recent certificates expiring on 31 March 2022.

Please refer to section 2 [2.1.a to 2.2.c] of the attached 2021/2022 tariffs document for the fees payable for the registrations renewal applications of the 2022/2025 farm feeds registration(s) renewal cycle.

Cheques must be made to the **Director General: Agriculture**. Please note that you may also make electronic payment and the bank account details are as follows:

- 3 Please further note that the application for renewal must reach the Registrar before **16:00 Thursday 31 March 2022**.
- 4 Application for renewal received after **Thursday 31 March 2022** will only be considered if received before **16:00 on Saturday 30 April 2022** and accompanied by the renewal fee plus the relevant late renewal application fee. Please refer to section 3 [3.1.(i) to 3.2.c(vii)] of the attached 2021/2022 tariffs document for the fees payable for late renewal registration application of the 2022/2025 farm feeds registration(s) renewal cycle.
- 5 Renewal application received by the Registrar's office after **30 April 2022** will not be considered.
- 6 Kindly be advised that if the renewal application for your farm feed product(s) is not received by the Registrar's office by **Saturday 30 April 2022**, the registration(s) thereof will automatically lapse and their sale must cease with immediate effect.

B. CANCELLATION FORM: FORM B

Form B must only be completed in respect of the farm feed(s) to be cancelled. The **original registration certificate(s)** of discontinued farm feeds must be returned together with Form B.

C. FORM C

Form C must be completed and submitted with Form A.

D. CONDITIONS FOR RENEWAL OF REGISTRATIONS

Renewal of registration will only be granted subject to the following conditions:

- (a) The composition of the farm feed concerned shall not deviate from the composition which is registered in respect thereof.
- (b) The particulars and wording which are approved to be indicated on a label or container used in connection with the sale of the farm feed concerned, shall not be altered without the prior written approval of the Registrar.
- (c) The conditions laid down during registration are adhered to, where applicable and
- (d) The registration concerned shall not in any manner or respect be transferable; and the bag/container sizes shall not be altered without prior written approval from the Registrar.
