#### Established Maximum Residue Limit: Malathion

The proposed maximum residue limit (PMRL) document for malathion notified in G/SPS/N/CAN/1291 (dated 7 January 2020) was adopted 18 March 2020. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL(ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity
0.8 Annual canarygrass seeds
