Description of content: Regulation (EU) 2017/625 ('Official Controls Regulation') empowers the Commission to adopt, by way of implementing acts, model official certificates which accompany animals and goods entering the Union, and rules for the issuance of such certificates. Regulation (EU) 2016/429 ('Animal Health Law') empowers the Commission to lay down, by way of implementing acts, rules concerning animal health provisions to be contained in those model official certificates.</p> <p>The purpose of this Regulation is to lay down rules for the issuance of such official certificates and to lay down specific models with regard to the category of goods and animals.</p> <p>The Regulation is launched as part of a package together with Implementing Regulation concerning model official certificates for certain terrestrial animals and Implementing Regulation concerning model official certificates for certain aquatic animals.</p>
