Notice of Modification to the List of Contaminants and Other Adulterating Substances in Foods to Update the Maximum Levels for Lead in Fruit Juice, Fruit Nectar and Water in Sealed Containers – Reference Number: NOM/ADM-C-2017-02

#### Background

Health Canada published a Proposal to Update the Maximum Levels for Lead in Fruit Juice, Fruit Water in Sealed Containers in the List of Contaminants Other Adulterating Substances in Foods - Reference number: [NOP/ADP C-2017-2] (https://www.canada.ca/en/health-canada/services/food-nutrition/public-involvementpartnerships/proposal-update-maximum-levels-lead-fruit-juice-fruit-nectar-water-sealedcontainers.html) on 1 March 2017 which was open to the public for comments for 75 days (G/SPS/N/CAN/1098). Although comments were provided during the comment period in response to this Notice of Proposal, as further described in the information document section "Notification -Summary of Comments", no new scientific information was submitted to the Department.

Therefore, <u>Health</u> Canada will update the maximum level for lead in fruit juice, fruit nectar and water in sealed containers, effective 14 May 2018, by modifying Part 2 of the *List of Contaminants and Other Adulterating Substances in Foods* (<a href="https://www.canada.ca/en/health-canada/services/food-nutrition/food-safety/chemical-contaminants/contaminants-adulterating-substances-foods.html">https://www.canada.ca/en/health-canada/services/food-nutrition/food-safety/chemical-contaminants/contaminants-adulterating-substances-foods.html</a>) as described in the information document. This date is twelve months following the close of the Notice of Proposal comment period.
