The following communication, received on 28 September 2017, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limit: Flonicamid

The proposed maximum residue limit (PMRL) document for flonicamid notified in G/SPS/N/CAN/1123 (dated 12 July 2017) was adopted 25 September 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
