#### Addendum

The following communication, received on 31 October 2017, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limit: Cyclaniliprole

The proposed maximum residue limit (PMRL) document for cyclaniliprole notified in G/SPS/N/CAN/1127 (dated 4 August 2017) was adopted 26 October 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
