Addendum

The following communication, received on 31 October 2017, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Cyclaniliprole

The proposed maximum residue limit (PMRL) document for cyclaniliprole notified in G/SPS/N/CAN/1127 (dated 4 August 2017) was adopted 26 October 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) ¹	Raw Agricultural Commodity (RAC) and/or Processed Commodity
15	Leafy vegetables (Crop Group 4-13)
1.0	Brassica head and stem vegetable group (Crop Group 5-13); stone fruits (Crop Group 12-09)
0.8	Small fruits vine climbing, except fuzzy kiwifruit (Crop Subgroup 13-07F)
0.3	Pome fruits (Crop Group 11-09)
0.2	Fruiting vegetables (Crop Group 8-09)
0.15	Cucurbit vegetables (Crop Group 9)
0.03	Tree nuts (Crop Group 14-11)
0.015	Fat and meat byproducts of cattle, goats, horses, and sheep; milk
0.01	Meat of cattle, goats, horses, and sheep

MRLs are established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html>) in the Pesticides and Pest Management section of Health Canada's website.
