The following communication, received on 8 December 2017, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Sulfentrazone

The proposed maximum residue limit (PMRL) document for sulfentrazone notified in G/SPS/N/CAN/1134 (dated 13 September 2017) was adopted 5 December 2017. The proposed MRL was were established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.15 Tuberous and corm vegetables (crop subgroup 1C)

 1 ppm = parts per million

MRLs are established for each commodity included in the listed crop groupings in accordance with Groups (https://www.canada.ca/en/healththe Residue Chemistry Crop webpage canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-yourhealth-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of Health Canada's website.
