Addendum

The following communication, received on 4 January 2018, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Chlorantraniliprole

The proposed maximum residue limit (PMRL) document for chlorantraniliprole notified in G/SPS/N/CAN/1142 (dated 13 October 2017) was adopted 20 December 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)¹</u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

40 Leaves of Root and Tuber Vegetables (Crop Group 2)

 1 ppm = parts per million

MRLs are established for each commodity included in the listed crop groupings in accordance with Groups (https://www.canada.ca/en/healththe Residue Chemistry Crop webpage canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-yourhealth-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of Health Canada's website.
