Established Maximum Residue Limit: Mefenpyr-diethyl

The proposed maximum residue limit (PMRL) document for mefenpyr-diethyl notified in G/SPS/N/CAN/1156 (dated 27 February 2018) was adopted 22 May 2018. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity
0.05 Annual canarygrass seeds, oats, rye, triticale
