Addendum

The following communication, received on 25 May 2018, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Prothioconazole

The proposed maximum residue limit (PMRL) document for prothioconazole notified in G/SPS/N/CAN/1157 (dated 27 February 2018) was adopted 22 May 2018. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

<u>MRL (ppm)¹</u>	<u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
0.35	Annual canarygrass seeds

¹ppm = parts per million
