<b>5. Title of the notified document:</b> Proposed Maximum Residue Limit: Oxathiapiprolin (PMRL2018-05). <b>Language(s):</b> English and French. <b>Number of pages:</b> 7 and 8
<b>6. Description of content:</b> The objective of the notified document PMRL2018-05 is to consult on the listed domestic maximum residue limits (MRLs) for oxathiapiprolin that have been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 80 Dried basil leaves 10 Brassica leafy greens (crop subgroup 4-13B); fresh basil leaves 2 Stalk and stem vegetables (crop subgroup 22A) 0.5 Caneberries (crop subgroup 13-07A) 0.04 Tuberos and corm vegetables (crop subgroup 1C) <sup>2</sup> <sup>1</sup> ppm = parts per million <sup>2</sup> The MRL of 0.04 ppm is proposed to replace the established MRL of 0.01 ppm for all crops in Crop Subgroup 1C.
