Addendum

The following communication, received on 28 June 2018, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Flonicamid

The proposed maximum residue limit (PMRL) document for flonicamid notified in G/SPS/N/CAN/1164 (dated 3 April 2018) was adopted 25 June 2018. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

<u>MRL (ppm)¹</u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

1.5 Citrus fruits (crop group 10 – Revised)

¹ppm = parts per million

MRLs are established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<u>https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html</u>) in the Pesticides and Pest Management section of Health Canada's website.
