Description of content: The objective of the notified document PMRL2018-20 is to consult on the listed maximum residue limits (MRLs) for sethoxydim that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 25 Mustard seeds (condiment type) ² , mustard seeds (oilseed type) ² ¹ ppm = parts per million ² The MRL is proposed to replace the currently established 2.0 ppm MRL for mustard.
