## Established Maximum Residue Limits: Clomazone

The proposed maximum residue limit (PMRL) document for clomazone notified in G/SPS/N/CAN/1227 (dated 6 December 2018) was adopted 27 February 2019. The proposed MRLs are established via entry into the Maximum Residue Limits Database and are provided directly below:
