## Established Maximum Residue Limit: Fluroxypyr-meptyl

The proposed maximum residue limit (PMRL) document for fluroxypyr-meptyl notified in G/SPS/N/CAN/1259 (dated 27 August 2019) was adopted 18 November 2019. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:
