Addendum

The following communication, received on 26 November 2019, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Pendimethalin

The proposed maximum residue limit (PMRL) document for pendimethalin notified in G/SPS/N/CAN/1267 (dated 30 August 2019) was adopted 25 November 2019. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)</u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.1 Head and stem *Brassica* (crop subgroup 5A), tomatoes subgroup (crop subgroup 8-09A)

ppm = parts per million

MRLs are established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<u>https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html</u>) in the Pesticides and Pest Management section of the Canada.ca website.
