## Addendum

The following communication, received on 28 September 2020, is being circulated at the request of the Delegation of Canada.

## Established Maximum Residue Limit: Inpyrfluxam

The proposed maximum residue limit (PMRL) document for inpyrfluxam notified in G/SPS/N/CAN/1314 (dated 2 July 2020) was adopted 23 September 2020. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity Legume vegetables (succulent or dried) (crop group 6); cereal grains (crop group 0.01 15); rapeseeds (crop subgroup 20A) (revised); apples; eqgs; fat, meat and meat byproducts of cattle, goats, hogs, horses, poultry and sheep; milk; peanuts; sugar beet roots

An MRL is established for each commodity included in the listed crop groupings in accordance with Chemistrv Crop Groups webpage (https://www.canada.ca/en/healththe Residue canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-yourhealth-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of the Canada.ca website.
