The proposed maximum residue limit (PMRL) document for MCPA notified in G/SPS/N/CAN/1320 (dated 29 July 2020) was adopted 21 October 2020. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

0.04 Annual canarygrass bran 0.03 Annual canarygrass seeds
