#### Addendum

The following communication, received on 9 November 2020, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limit: Pendimethalin

The proposed maximum residue limit (PMRL) document for pendimethalin notified in G/SPS/N/CAN/1325 (dated 12 August 2020) was adopted 2 November 2020. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity 0.1 Bulb onions (crop subgroup 3-07A, except dry bulb onions)<sup>2</sup>

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<a href="https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html">https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html</a>) in the Pesticides and Pest Management section of the Canada.ca website.
