Established Maximum Residue Limit: Acephate and Methamidophos

Modification of final date for comments

The proposed maximum residue limit (PMRL) document for acephate and methamidophos notified in G/SPS/N/CAN/1331 (dated 25 August 2020) was adopted 16 November 2020.

As per PMRL2020-24, the revision and revocation of the MRLs for acephate and methamidiphos on corresponding commodities will take effect to allow sufficient time for legally treated commodities to clear the channels of trade.
