The following communication, received on 22 January 2021, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Glufosinate-ammonium

The proposed maximum residue limit (PMRL) document for glufosinate-ammonium notified in G/SPS/N/CAN/1346 (dated 23 October 2020) was adopted 18 January 2021. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

<u>MRL (ppm)¹</u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.3 Strawberries

¹ ppm = parts per million
