The following communication, received on 20 May 2021, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Thiabendazole

The proposed maximum residue limit (PMRL) document for thiabendazole notified in G/SPS/N/CAN/1376 (dated 19 February 2021) was adopted 19 May 2021. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)¹</u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

10Mangoes, papayas9.0Bananas²

¹ ppm = parts per million

² This MRL replaces the current MRL of 0.4 ppm for bananas.
