The following communication, received on 2 June 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Pyraziflumid

The proposed maximum residue limit (PMRL) document for pyraziflumid notified in G/SPS/N/CAN/1427 (dated 7 March 2022) and G/SPS/N/CAN/1427/Corr.1 (dated 3 May 2023) was adopted 31 May 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:
