Addendum

The following communication, received on 4 August 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Topramezone

The proposed maximum residue limit (PMRL) document for topramezone notified in G/SPS/N/CAN/1435 (dated 2 May 2022) was adopted 27 July 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)¹</u> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Fat and meat by-products of poultry²

0.01 Rapeseeds³ (crop subgroup 20A) (revised); eggs and meat of poultry²

¹ ppm = parts per million

² From poultry consumption of feed treated with topramezone.

³ Canola is a variety of rapeseed.
