Addendum

The following communication, received on 4 August 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Pyraclostrobin

The proposed maximum residue limit (PMRL) document for pyraclostrobin notified in G/SPS/N/CAN/1436 (dated 2 May 2022) was adopted 27 July 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity 1.5 Azaroles, Chinese quinces, Japanese quinces, medlars, tejocotes 0.9 Beltsville bunching onions, daylilies, elegans hosta, fritillaria bulbs, fritillaria leaves, fresh Chinese chive leaves, fresh onions, kurrats, lady's leeks, lilies, macrostem onions, pearl onions, serpent garlic, shallot bulbs², shallot leaves, wild leeks
