#### Addendum

The following communication, received on 4 August 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limit: Fluopyram

The proposed maximum residue limit (PMRL) document for fluopyram notified in G/SPS/N/CAN/1437 (dated 2 May 2022) was adopted 27 July 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

## MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.5	Cereal grains (crop group 15), except rice and corn <sup>2,3</sup>
0.3	Rapeseeds (crop subgroup 20A) (revised) <sup>4</sup>
0.03	Green coffee beans
0.02	Field corn, popcorn grain <sup>2</sup>
0.01	Sweet corn kernels plus cob with husks removed <sup>2</sup>

<sup>&</sup>lt;sup>3</sup> The MRL of 2.0 ppm for wheat bran and germ has been revoked. These wheat commodities are now regulated under the cereal grains (crop group 15) MRL of 0.5 ppm.

<sup>&</sup>lt;sup>4</sup> This MRL replaces the established MRL of 1.8 ppm for rapeseeds (crop subgroup 20A) (revised).
