The following communication, received on 12 September 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Oxathiapiprolin

The proposed maximum residue limit (PMRL) document for oxathiapiprolin notified in G/SPS/N/CAN/1440 (dated 10 June 2022) was adopted 4 September 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

5.0 Hops (dried cones)

0.01 Dry soybeans; sunflower seeds; eggs; fat, meat and meat by-products of poultry

¹ ppm = parts per million
