Description of content: The objective of the notified document PMRL2022-19 is to consult on the listed maximum residue limits (MRLs) for florylpicoxamid that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.02 Eggs; fat, meat, and meat by-products of cattle, goats, horses, hogs, poultry and sheep; milk 0.015 Rapeseeds (crop subgroup 20A) (revised) 0.01 Dried shelled beans, except soybeans (crop subgroup 6-21E); dried shelled peas (crop subgroup 6-21F); wheat (crop subgroup 15-21A); sugar beet roots ¹ ppm = parts per million The commodities included in the listed crop groups/subgroups can be found on the <i>Residue Chemistry Crop Groups</i> webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides section of the Canada.ca website.
