#### Addendum

The following communication, received on 25 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limit: Oxathiapiprolin

The proposed maximum residue limit (PMRL) document for oxathiapiprolin notified in G/SPS/N/CAN/1482 (dated 23 February 2023) was adopted 18 May 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

## MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.1 Tropical and subtropical, medium to large fruits, smooth, inedible peel (crop subgroup 24B)
