#### Addendum

The following communication, received on 25 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limits: Benzovindiflupyr

The proposed maximum residue limit (PMRL) document for benzovindiflupyr notified in G/SPS/N/CAN/1485 (dated 28 February 2023) was adopted 22 May 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

#### MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

- 3.0 Leaves of root and tuber vegetables (crop group 2)
- 0.6 Root vegetable except sugar beet (crop subgroup 1B, except ginseng roots)
- 0.3 Ginseng roots
