	The results of the premarket assessment support the safety of carboxypeptidase D from <i>A. oryzae</i> AT1727 for its requested uses. Consequently, Health Canada has enabled the use of carboxypeptidase D from this source as described in the information document by modifying the <i>List of Permitted Food Enzymes</i> , effective 23 May 2023.
