Addendum

The following communication, received on 22 September 2023, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Spiromesifen

The proposed maximum residue limit (PMRL) document for spiromesifen notified in G/SPS/N/CAN/1511 (dated 21 June 2023) was adopted 17 September 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

1.0 Green onions (crop subgroup 3-07B)

¹ppm = parts per million
