Addendum

The following communication, received on 8 November 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Chloropicrin

The proposed maximum residue limit (PMRL) document for chloropicrin notified in G/SPS/N/CAN/1513 (dated 21 June 2023) was adopted on 3 November 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.025 Stalk, stem, and leaf petioles (crop group 22)²

¹ppm = parts per million

² The MRL replaces the previous MRLs of 0.025 ppm in/on asparagus, cardoon, celery, celtuce, Chinese celery, fresh Florence fennel leaves and stalks, kohlrabies and rhubarb with a single crop group 22 MRL.
