The requested maximum level of use for this food enzyme is Good Manufacturing Practice.
	The results of the premarket assessment support the safety of xylanase from <i>T. reesei</i> RF5427 for its requested uses. Consequently, Health Canada has enabled the use of xylanase from this source as described in the information document by modifying the <i>List of Permitted Food Enzymes</i> , effective 3 August 2023.
