Title of the notified document: Draft Commission Regulation (EU) amending Annex II to Regulation (EC) No 396/2005 of the European Parliament and of the Council as regards maximum residue levels for dimethoate and omethoate in or on cherries (Text with EEA relevance). Language(s): English. Number of pages: 3+6
6. Description of content: The proposed draft Regulation concerns the review of the existing maximum residue levels (MRLs) for the substances dimethoate and omethoate. MRLs for these substances in cherries are lowered. Lower MRLs are set after updating the limits of determination and/or deleting old uses which are not authorised any more in the European Union or for which a human health concern may not be excluded.

Based on that opinion, Regulation (EC) No 396/2005 should be amended following a risk analysis approach.
