Description of content:</b> The notified regulation authorises the use of polysorbates (E 432-436) as an antifoaming agent at 10 mg/l in carbonated beverages (i.e. in flavoured drinks, cider and perry, fruit wine and made wine and alcoholic drinks including mixtures of alcoholic drinks with non-alcoholic drinks and spirits with less than 15% of alcohol)
