Nature of the urgent problem(s) and reason for urgent action: This MO was issued based on the official report submitted by Dr Krzysztof Jazdzewski, Deputy Chief Veterinary Officer, Ministry of Agriculture and Rural Development, Genral Veterinary Inspetorate, Varsovie, Poland to the World Health Organization for Animal Health (OIE) on 18 January 2017, confirming that there were thirty-one outbreaks of H5N8 Highly Pathogenic Avian Influenza (HPAI) virus in eight provinces from 1 December 2016 to 18 January 2017. It affects backyard holdings and farms for birds as confirmed by the National Veterinary Research Institute (National laboratory).
