The following communication, received on 28 May 2019, is being circulated at the request of the Delegation of the <u>Kingdom of Saudi Arabia</u>.

Technical Regulation for Added Sugar Upper Limit in Some Food Products

Modification of final date for comments

This Technical regulation applies to all food products that contain added sugar, except the following:

- Drinking soda that contains natural and/or artificial sweeteners such as Diet, Lite, Zero, etc.;
- Food for special dietary uses.

In 26 April 2019, the Kingdom of Saudi Arabia notified WTO (SPS) about this Technical Regulation (G/SPS/N/SAU/396). Due to the valuable comments from many WTO Members, this Technical regulation will be reviewed by Saudi Arabia. This technical regulation shall not come into force until further notice.
