Description of content:</b> This mandatory standard establishes requirements on good agricultural practices for the management of commercial layer farm, covering farm components, managements of farms, animal feed, water, personnel, animal health, animal welfare, pullets and layer hens, eggs and environment including record keeping. This standard aims to support the production of good quality eggs which are safe for consumers.  This standard does not cover eggs produced from layer farms that are certified by the Department of Livestock Development (DLD) under other standards such as the Thai Agricultural Standard on Organic Agriculture Part 2: Organic Livestock (TAS 9000 Part 2) and standards on free range layer farming.
