#### Standards for veterinary drug residue limits in foods

The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu proposed amendments to the Standards for veterinary drug residue limits in foods on 7 September 2020 (G/SPS/N/TPKM/549) has now been finalized. The final version of the Standard will enter into force on 1 January 2021.
