NEWS RELEASE BY MINISTER R. F. (PIK) BOTHA, ACTING MINISTER OF AGRICULTURE

STEPS TAKEN BY THE DEPARTMENT OF AGRICULTURE REGARDING IMPORTATION OF BEEF FROM THE UNITED KINGDOM

On the advice of officials of the Department of Agriculture, Minister Pik Botha, in his capacity as acting Minister of Agriculture, has temporarily suspended the importation of beef from the United Kingdom. The suspension is immediately effective.

This step follows on the great concern amongst the South African public about the latest developments regarding the occurrence of BSE (also called mad cow disease) in cattle in the United Kingdom. The temporary suspension will give the Departments of Agriculture with the assistance of Health in Sough Africa the opportunity to urgently confer with their counterparts in the United Kingdom and to clear up the position regarding the certification of beef From the UK to be free of BSE. Arrangements are now being made for a high level technical team to visit the UK for this purpose.

The relatively small quantities of beef imported from the UK have all been certified by the British Veterinary authorities as free from BSE and therefore safe for human consumption.

Unfortunately the virus or sub-virus causing the disease cannot be detected in meat by routine inspection. However, as it only occurs in nervous and lymphatic tissues of affected cattle, special precautions were taken by the South African authorities in the past. Only manually deboned meat of which the nervous tissue, lymphatic tissue and glands were removed were allowed to be imported. Furthermore the United Kingdom authorities had to certify that only beef originating from a herd where no case of BSE occurred during the previous five years could be cleared for export to South Africa. This certification was received by the South African Veterinary Authorities in all cases of meat already imported. The public can therefore rest assured that every precaution was taken to ensure that no BSE-infected beef was imported.
