## NOTIFICATION OF EMERGENCY MEASURES

Agency responsible: Directorate Animal Health, National Department of Agriculture **3.** Products covered (provide tariff item number(s) as specified in national schedules deposited with the WTO; ICS numbers should be provided in addition, where applicable): Live pigs, pig genetic material, pork (fresh and processed), and all pork products and by-products. Processed pig products including: (i) meat treated to inactivate the Classical Swine Fever virus according to Article 3.6.4.2 of the OIE Animal Health Code 2005 Edition, and (ii) fully mounted trophies, salted hides, or tusks dipped in formalin that have been suitably treated and disinfected, are all excluded. 4. Regions or countries likely to be affected, to the extent relevant or practicable: All trading partners 5. Title, language and number of pages of the notified document: Temporary suspension of exportation of live pigs, pig genetic material, pork (fresh and processed) and all pork products and by-products from South Africa due to outbreaks of Classical Swine Fever (Available in English, 2 pages). 6. **Description of content:** Following the reported outbreaks of Classical Swine Fever in South Africa, it is deemed necessary for South Africa to prevent spread of the disease to other countries. The exportation of live pigs, pig genetic material, pork (fresh and processed) and all pork products and by-products is temporarily suspended. This suspension will remain in place until results from a country-wide surveillance for Classical Swine Fever are available. Processed pig products including: (i) meat treated to inactivate the Classical Swine Fever virus according to Article 3.6.4.2 of the OIE Animal Health Code 2005 Edition, and (ii) fully mounted trophies, salted hides, or tusks dipped in formalin that have been suitably treated and disinfected, are all excluded from this notification. 7.
