- **5. Title, language and number of pages of the notified document:** Complete lifting of ban of exportation of live ostriches, live poultry and other birds, and ostrich and poultry products from South Africa, due to eradication and declared freedom from Notifiable Avian Influenza (Available in English, 2 pages).
- (NAI) in ostriches in South Africa in 2004, it was deemed necessary for South Africa to suspend exportation of live ostriches, live poultry and other birds, and ostrich and poultry products to prevent spread of the disease to other countries. South Africa has now declared itself free of Notifiable Avian Influenza according to the guidelines set by the International Organization for Animal Health (OIE) on the basis of a successful control and eradication campaign as demonstrated by the results obtained during an extensive country-wide survey in ostriches and chickens during August 2005. The ban on exportation of live ostriches, live poultry and other birds, and ostrich and poultry products is now lifted completely. It should be noted however that the actual export conditions still depend on the requirements of each importing country. Surveillance testing will also be carried out in ostrich and chicken flocks at 6 monthly intervals to confirm South Africa's ongoing disease-free trading status for NAI.
