- 6. **Description of content:** Following a notification published by the World Organization for Animal Health (OIE) regarding the outbreak of Highly Pathogenic Avian Influenza virus (HPAI) in poultry in Zimbabwe, South Africa is applying precautionary sanitary measures to prevent the risk of introducing HPAI virus through the imports of live birds and their products from Zimbabwe. These measures include temporary bans on the importation of live poultry, pigeons and other birds, eggs (excluding SPF eggs) and fresh (including frozen) poultry meat from Zimbabwe.
- 7. Objective and rationale: [] food safety, [X] animal health, [] plant protection, [] protect humans from animal/plant pest or disease, [] protect territory from other damage from pests.
- **8. Nature of the urgent problem(s) and reason for urgent action:** There is a risk of contamination from importing poultry, live birds and poultry products from Zimbabwe, which are affected with Highly Pathogenic Avian Influenza. This follows the notification of Highly Pathogenic Avian Influenza in poultry in Zimbabwe. This applied measure is in compliance with Article 10.4.3, Chapter 10.4 of the World Organization for Animal Health (OIE) Terrestrial Animal Health Code.
