1.	Kindly confirm if the required cabinet must be on dark cherry or dark mahogany?	All 15 x cabinet must be in Dark Mahogany Veneer as as indicated on the on specification.
2.	Where will be the key cabinet be placed? How many keys should the cabinet accommodate?	The cabinet will be the mounted/hanged on the wall. The cabinet should accommodate 300 keys.
3.	Kindly note that the required three-seater silver line heavy duty steel bench is not available in Genuine Leather, can we propose the Black Pleather	We request the bench to be upholsted with black genuine leather as indicated on the specification.
4.	Item number 5 on the specification it indicates that the required material be on black nylon upholstered fabric, but on the market the same item you will only get it on black bonded leather or black fabric. Can we propose that the required item be on black bonded leather or black fabric?	The visitor chair should be in black fabric and not nylon as specified.
5.	Item 6 on the specifications are imported chairs. Can we supply the same or similar looking chairs?	The picture is just a sample but we need something similar or equivalent to the sample as per the TOR or specifications. The information as per local content is supported by the Department of Trade and Industry and thus states the composition of local content. If the product is imported an exemption certificate should be requested from DTI.
7.	Kindly Confirm the Mechanism required on item 7 (draughtman chair). Can we supply a Black Base?	The mechanism should be able to swivel and tilt as specified on the specifications. We prefer a silver base.

	Can the required item 7 be supplied on Upholstered Back or Netted Back ?	black fabric upholstery should be supplied.
8.	Should the high back chair on item 8 be a Heavy Duty Chairs. Kindly Confirm the mechanism required on item 8? Do you require Height Adjustable Arms?	The chair should be heavy duty. The mechanism should be able to swivel and tilt as specified on the specifications. There should be height adjustable arms as per the specifications.
9.	Item 6 on the specifications are imported chairs. Can we supply the same or similar looking Desks? The Cherry & Mahogany Veneer Colours are imported Colours. We match the Veneer Colours as close as possible with Local Manufacturers. It will look similar? If the product is imported an exemption certificate should be requested from DTI. The desks should be on Dark Mahogany and Cherry Veneer as specified on TOR
