(Verification Agencies accredited by SANAS or Sworn Affidavit signed by the deponent and attested by the Commissioner of Oaths to substantiate their BBBEE rating claims.)

NB: The department reserves the right to request bidders to submit their current Audited Financial Statement/s.

Note: Any tender not complying with the above-mentioned stipulation, will be regarded as non-responsive and will therefore not be considered for further evaluation.

Preferential Procurement Policy Framework Act (PPPFA), Act no. 5 of 2000 and Preferential Procurement Regulation, 2017. The 80/20 Preference Point system will be applied where a maximum of Eighty (80) tender adjudication points will be awarded for price and Twenty (20) points will be awarded for preference.
