#### 1. INTRODUCTION

## 2. BACKGROUND

The primary goal of the government of South Africa (GoSA), as articulated in the National Development Plan (NDP 2012-2030), is to create jobs through its productive sectors, especially agriculture. The NDP has as its overarching objective to create one million additional jobs in the agricultural sector by 2030 and bring one million hectares of land under production in the same period. Given this plan, the GoSA proposed to develop 44 agri parks across the nine provinces in the country.

Established in 2015, the approach of the South Africa Agri-Park Program (SA-APP) is to capitalize on the strengths of small towns and revitalize the economies of these towns through crowding-in of investments for agricultural and other value chains development. SA-APP ecosystem consists of a Farmer Production Support Unit (FPSU), an Agri Hub (AH) and a Rural Urban Market Centre (RUMC). Given the magnitude of infrastructure investments required in each of these components, an efficient institutional framework is required to implement the program. The purpose is to create an enabling environment for competitive value addition which will help drive demand for farm produce and increase productivity for priority value chains like Maize, Oil Seeds, Horticulture and Livestock.

The SA-APP model is in direct alignment with the African Development Bank's (AfDB) program of developing Special Agro Processing Zones (SAPZ) in Africa. The Bank in

collaboration with the Department of Agriculture, Land Reforms and Rural Development (DALRRD) has prioritized nine of the 44 Agri-parks for development.

Given available resources under this Grant, the technical assistance will focus on two of the nine prioritized Agri Parks namely Tsiame Agri-park located in the Free State Province and Springbokpan Agri-park, located in the North West Province.

In June 23, 2020, the GoSA hosted the Sustainable Infrastructure Development Symposium. The outcome of the Symposium has since culminated in the identification and gazetting of Strategic Integrated Projects (SIPs) consisting of 55 SIPs project and 14 Special Projects. The goal of this proposal is to graduate the South Africa Agri Park program to the Sustainable Infrastructure Development System (SIDS) methodology at the IIO in the Presidency for coordination, bring the project to financial closure and provide an operations and management structure that will enable investors to provide investment funds for infrastructure development and attract private sector investment to the SA-APP sites in the respective provinces.

The Department of Agriculture, Land Reforms and Rural Development of the Republic of South Africa, therefore, require the services of a Consultant/Team of Consultants/Consultancy Firm to carry out a Feasibility Study and Development of a Plan for the setting up of Agri Parks in two Provinces in the Republic of South Africa.

## 3. OVERALL OBJECTIVE

The general objective is to engage a transactions advisor that will provide technical assistance and an implementation management structure for two of the South Africa Agri Park projects in the Free State and the Northwest Province. The Transaction Adviser (TA) will assist the Department of Agriculture, Land Reforms and Rural Development (DALRRD) in providing critical technical, financial, legal and marketing support for the establishment of the South Africa Agri Park Program. Emphasis is on enabling private sector development of the Agri Parks and at the same time ensure the integration of rural producers and small businesses with commercial value chains and markets; encourage the inclusion of informal economic actors into the formal system; enhance the business climate to mobilize private capital; and integrate youth into agriculture as a business enterprise and source of employment.

The aim of the assistance is to undertake *inter alia* the procurement of a Project Team to undertake (and/or validate existing) full feasibility studies and Master Plans for the Agri Parks and associated Farmer Production Support Units (FPSU) and Rural Urban Market Centers (RUMC), undertake an Environmental and Social Impact Assessment (ESIA), develop other required technical studies (including skills gap assessment, Climate Risk, Gender Report, and Green House Gas (GHG) performance assessments) and coordinate with the Investment and Infrastructure Office of the Presidency to ensure that the required Reports meet the standards for Strategic Infrastructure Projects (SIPs). #### 6. SCOPE OF WORK

The scope of work will include but not limited to the following:

- Review and update key available documents for the Agri-Parks program broadly and more specifically for the two pilot Agri-Hubs of Tshiame, FS and Springbokpan, NW (these will include Due diligence reports, Feasibility reports, Master plans, Business Plans, Implementation Plans and other),
- Undertake and/or validate the Feasibility studies and Master plans for the 2 Agro Parks including the associated Farmer Support Production Units and Rural Urban Market Centres for commercial viability.
- Propose Value Chain Development and Analyses for the two sites in terms of key commodities and their backward – and forward linkages and market development opportunities (supply vs demand) and

- Complete the feasibility studies and master plans and establish the commercial attractiveness and bankability of the projects to meet the standards of the Strategic Infrastructure Projects (SIPs) in South Africa.
- The consultant will together with the DALRRD provide the updated and/or the revised project documents (full feasibility Studies and Master plans) to the Investment and Infrastructure Office (IIO) in the Presidency for gazetting as Strategic Integrated Projects (SIPS).
- Provide Technical, Financial and Legal support to the DALRRD and institutional partners and bring each Project to financial close.

  - Establish the baseline using primary and secondary data available from various government published reports on air, meteorology, water, soil, flora and fauna, socioeconomics, infrastructure, sensitive areas (forests, archaeological, historical etc) in relation to the project site.
  - Describe all elements of the project activities and their project area of influence during the pre-construction, construction, and operational phases. The elements to be analysed include the infrastructures of the project including drainage features, roads, waste collection, disposal and management and utility requirements, including alternative analysis of sites and project design.
  - Comprehensively analyse the environmental and social institutional, policy and regulatory framework relevant to the project and explain how the project will ensure compliance.
  - Identify and assess direct, indirect, and cumulative impacts.

Undertake a risk assessment (RA) and disaster management plan (DMP) describing the probable risks and preventive and precautionary measures to be followed in the event of emergency situations such as accidents, fire etc.

• Undertake a Climate Risk Assessment and Management Plan -

- **First payment**: 20 % upon submission of final inception report
