

1. COUNTRY'S SNAPSHOT1

Area: 77 700 km² excluding islands, of which 97% is desert

Population: 7.5 mil (2012)

Languages: Arabic, English widely understood

2. UAE ECONOMY²

The GDP at market exchange rate was U\$\$383 799 million in 2012, with a real growth rate of 4.4%. Estimated consumer inflation was 0.7% in 2012. The current account surplus in 2013-17 is expected to average around 8.5% of GDP. The GDP per head (US \$ at market exchange rate) is estimated at \$ 55 490 for 2012. Table 1 indicates the major exports and imports of UAE in 2011.

4. UAE IMPORTS FROM THE WORLD 4

Table 2 indicates the top 30 imports of agricultural/forestry/fisheries products by UAE from the world. It is noted that "Lumber, coniferous (softwood) 6 mm and thicker" is the only forestry product that is under the top 30 imports of agricultural/forestry/fisheries products. No fishery products are represented under the top 30 imports by the UAE from the world.

5. SA'S TRADE WITH UAE 5

5.1 Trade Balance for all products traded between SA and the UAE

Table 3 indicates the trade balance for all products between the UAE and SA. The major import by SA from the UAE is mineral fuel and oil.

5.2 Trade Balance for agricultural/forestry/fisheries products traded between SA and the UAE

Table 4 indicates that for the period 2008 to 2012, SA had a trade surplus in agricultural/forestry/fisheries products traded with UAE. During this period the imports of agricultural/forestry/fisheries products by SA from the UAE were less than R150 000 a year, while the average exports were more than 1 billion a year.

5.3 Agricultural/forestry/fisheries products traded between SA and UAE

Table 5 indicate the top agricultural/fishery/forestry products that SA has exported to the UAE. No fisheries products were under the top exports, while Sack Kraft Paper (HS 480421), Kraftliner (HS 4804190) and Forage Products (HS 121490) [forestry products) were under the top exports. The rest of the top exports in 2012 were agricultural products.
