- All former public servants who have successfully completed their 24-months cooling-off period (after leaving the public service); g.
- h. Former public office bearers who have successfully completed their 12-months cooling-off period (after leaving public office);
- A minimum of five (5) years' experience in horticulture/crop production. i.

- b. In the case of a natural person: Certified copy of the applicant's barcoded South African ID;
- In the case of a juristic person: Unabridged legal entity registration certificate, certified copies of all members' South African IDs, and a C. Resolution appointing a representative of the legal entity;
- d. In case of livestock, Brand Mark Certificates must be attached;
- e. Schedule of own farming assets, e.g., livestock, farm implements and machinery;
- f. Proof of financial resources to cover the first production cycle or to acquire livestock.
